Policy Statement

Health and Safety Principles

- Every individual is responsible and accountable for their own health and safety and that of others.

- Operating in accordance with current legislative and regulations requirements and other obligations, ensuring full legal compliance
- Allocating resources to achieve measurable OH&S objectives and targets that support continual improvement in safety performance
- Ensuring the safety of our people as a value that is never compromised, with a commitment to preventing injury and ill
 health
- Recognising that safety excellence is integral to good business and fundamental to our operational success
- Training all personnel associated with the operation to ensure they are aware of their specific safety responsibilities, and encouraging worker active participation and consultation in OH&S matters
- Identifying, assessing, and managing risks to employees as part of our commitment to eliminating hazards and reducing OH&S risks
- Documenting procedures to minimise safety risks associated with the operation, supporting hazard control and standardised practices
- Building a culture of risk awareness and proactive hazard reduction across our operations, in alignment with our continual improvement goals
- Holding our employees and contractors responsible and accountable for their own safety performance, and promoting ownership of safe behaviours
- Investigating health and safety incidents and implementing corrective actions to prevent recurrence and strengthen system resilience
- Promoting continual improvement by monitoring, evaluating, and enhancing our health, safety, and well-being programs and performance
- Periodically reviewing our OH&S policies and procedures to ensure their continued relevance, effectiveness, and alignment with ISO 45001 requirements
- Integrating safety considerations into all aspects of our planning, operations, and processes to embed OH&S into core business decisions
- Empowering employees to stop work immediately if they believe the work to be unsafe, reinforcing our commitment to prevention and a just safety culture, and
- Upholding human rights by ensuring fair and equal access to a safe, healthy, and respectful work environment for all.
